Dear Parents,

The City of Westlake Village's Westlake Transit program will once again offer a summer route. The route is part of a regional program being offered in conjunction with the City of Agoura Hills. The route will have two stops in Westlake Village, two stops in Agoura Hills, and then proceed to Calabasas High. **Please note, all stops will require a Dual City Transit bus pass or passengers have the option of paying a \$2 fare for each way.** Similar to previous summer programs, the summer route will coincide with summer school schedules for high school students.

The price for a round-trip pass for the school year is **\$75** per student and a one-way pass for either mornings or afternoons is **\$50**. For those not wishing to purchase a summer pass, the individual one-way fare is **\$2** per trip, which is payable upon boarding the bus.

The Cities offer two options for bus pass purchase:

1. **In Person** at Westlake Village City Hall or at the Agoura Hills Recreation Center
2. **Via the Westlake Village City Website with a Credit Card** - Online credit card processing will be available after June 1 for bus pass sales. Check the City website, www.wlv.org, under "Westlake Village Transit" for more information to process this form of payment and registration. After completing your online application and credit card purchase, bus passes will be mailed to your home. The final date for ordering online to receive your pass for the first day of school is June 8.

**CITIES OF AGOURA HILLS AND WESTLAKE VILLAGE
BUS PASS RULES OF CONDUCT
SUMMER SHUTTLE 2018**

FAILURE TO ADHERE TO THE FOLLOWING RULES MAY RESULT
IN LOSS OF TRANSPORTATION PRIVILEGES

1. Bus Pass or \$2 bus fare must be presented in order to board the bus each way.
2. No spitting or throwing objects into or from open windows.
3. No smoking or lighting of matches.
4. No swearing or using foul language, yelling, screaming, or whistling.
5. No putting of feet on the seats or in and/or across the aisle.
6. No horseplay, jabbing, or teasing.
7. No eating, drinking, or littering on the bus.
8. No putting of arms, hands, legs, or feet out of bus windows or doors.
9. No intimidating or threatening of anyone on the bus.
10. Animals, insects, or reptiles are not allowed on the bus.
11. Large bulky items, glass, firearms, and knives are prohibited.
12. Shoes must be worn at all times.
13. Seat belts must be securely fastened at all times.
14. Riders must sit facing the front of the bus at all times.
15. Riders must get on and off the bus at the proper stop and cross the street in the proper manner.
16. Riders must obey the bus driver and follow directions at all times.
17. The following infractions will result in immediate revocation of transportation privileges:
 - a. Fighting at a bus stop or on a bus.
 - b. Actions which endanger the safety of a person at a stop, on the bus, or persons near a bus while in transit.
 - c. Damage to property at a bus stop or on the bus.
 - d. Refusal to follow the directions of the driver.
 - e. Tampering with controls, emergency equipment or exits.

If a pass holder should be denied transportation for disciplinary reasons, there will be NO REFUND GRANTED.
