## **A Message From Kelly Honig – Mayor Of Westlake Village March 16, 2020**

Considering the rapidly evolving situation that is unfolding with the Novel Coronavirus (COVID-19), your City Council and City staff are working to keep everyone updated with the latest news affecting services and facilities in our Community. We continue to disseminate critical Novel Coronavirus information, and we urge all citizens to closely follow the L.A County Department of Public Health and Center for Disease Control (CDC) guidelines for health updates.

Please practice social distancing, avoid groups of people, limit non-essential trips and stay home if you are feeling sick. If you can work from home, do so. Wash your hands often with soap and water and if soap is not readily available, use an alcohol-based hand sanitizer with at least 60% alcohol.

As of today, Monday, March 16, Westlake Village City Hall is closed to the public. All City events have been cancelled through the end of March. This decision has been made to protect the health of our community members as well as our City staff.

### **The status of services in the community are as follows:**

- A special City Council meeting will be held at 4pm on Tuesday, March 17, 2020.
- Essential services including Sheriff, Fire, and emergency medical assistance are fully functional currently.
- LA County Public Health and the LA County Board of Supervisors has ordered all bars, nightclubs, wineries, brew pubs, fitness centers, and movie theaters to close as of today, Monday, March 16. Restaurants are directed to move to take-out only options. Grocery stores and pharmacies remain open. This directive applies to all 88 cities in Los Angeles County, including Westlake Village, and unincorporated regions of Los Angeles County.
- Las Virgenes Unified School District (LVUSD) has closed all facilities for a minimum of two weeks beginning Monday, March 16 and lasting through March 27th.

- County animal control facilities are closed to the public. The Department of Animal Care and Control will continue to respond to emergency calls for service. For emergency animal control services, contact the Agoura Hills dispatch line at: (818) 991-0071.
- Las Virgenes Municipal Water District (LVMWD) has confirmed that tap water is safe for consumption and services will be uninterrupted.
