SUBJECT: CERTIFICATION OF NOVEMBER 8, 2022 GENERAL MUNICIPAL ELECTION RESULTS FOR THREE COUNCILMEMBER POSITIONS; RESOLUTION NO. 2279-22

The County of Los Angeles, Registrar-Records/County Clerk Dean Logan has submitted the Certificate of the Canvass of the Election Returns for the City of Westlake Village, allowing the City Clerk to finalize the draft Resolution that was originally attached to the staff report on tonight's agenda (NB No. 1).

Westlake Village has 6,342 registered voters and 4,295 ballots were cast for the November 8, 2022 Election for three City Councilmembers. For the 4,295 ballots cast, 721 were at Vote-Centers and 3,574 on Vote-by-Mail Ballots.

RESOLUTION NO. 2279-22

**A RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF WESTLAKE VILLAGE
RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION
HELD ON NOVEMBER 8, 2022, AND DECLARING THE RESULT
AND SUCH OTHER MATTERS AS PROVIDED BY LAW**

WHEREAS, a General Municipal Election was held and conducted in the City of Westlake Village on Tuesday, November 8, 2022, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; voting precincts were properly established; election officers were appointed; and in all respects the election was conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the Elections Code for the holding of elections in general law cities; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit A.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WESTLAKE VILLAGE, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

Section 1. That the whole number of ballots cast in the precincts except vote by mail ballots delivered was 721, and the whole number of vote by mail voter ballots cast was 3574, making a total of 4295 ballots cast in the City.

Section 2. That the names of persons voted for at the election for Member of the City Council were as follows: Marc Bakerman, Ray Pearl, Susan McSweeney, Brad Halpern, and Pam Johnson.

Section 3. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates are listed in the attached Exhibit A.

Section 4. The City Council determines and declares that Brad Halpern, Susan McSweeney, and Ray Pearl were elected as Members of the City Council for the full term of four years. Each such elected Member of the City Council will serve for the full term of four years, effective December 7, 2022 through December 2026, and until their successors are elected and sworn-in.

Section 5. The City Clerk shall enter on the records of the City a statement of the results of the election, showing: (1) the whole number of ballots cast in the City; (2) the names of the persons voted for; (3) for what office each person was voted for; (4) the number of votes given at each precinct to each person; and (5) the total number of votes given in the City to each person.

Section 6. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated. A Judge shall administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

Section 7. The City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original resolutions.

PASSED, APPROVED and ADOPTED this 7th day of December, 2022.
